CyberLynx Computer Assignment Agreement

With a \$200 (out of pocket) deposit families will receive a new PC computer. Beginning with the current school year, a withdrawal will be taken from the student allotment to pay for the computer. For a laptop, the withdrawal will be \$325 and a desktop will be \$250 a year. At the end of a three-year period students/families may purchase the computer by forfeiting their deposit. The computers will come with a 3-year service warranty.

The following are the terms by which I accept possession of the computer equipment assigned by the CyberLynx Correspondence Program:

I understand that a \$200 equipment security deposit is required and that the Nenana office must receive the deposit with this signed agreement before the equipment will be ordered or delivered. No equipment will be delivered to locations outside of Alaska. I understand that this equipment remains the property of Nenana City Public School (NCPS) subject to the property transfer conditions described in this agreement.

I understand after three years participating in this computer program that if the computer is not returned by June 30th of the current school year, I am authorizing Nenana City School District to keep the \$200 computer deposit and the computer becomes my property.

I understand that no parts of the computer may be removed and no alterations may be made to the hardware while the computer is the property of Nenana City School District. The computer is to remain in our place of residence and NCPS will be notified of all address changes.

I understand that NCPS is NOT RESPONSIBLE for any information accessed on the internet nor for software troubleshooting or hardware repair issues. These situations are covered by the manufacturers support warranty.

I understand that the equipment security deposit is fully refundable upon return of the computer prior to the June 30th of the 3rd year in CyberLynx. The \$200 deposit will be forfeited if the following occurs:

- Equipment is returned in poor or damaged condition.
- Software/original packaging/documentation are missing
- The computer is not returned

I understand that only one computer is provided per family *unless* the family full-time student count is four or more students, a second computer can be obtained with an additional \$200 deposit and signed agreement form. A quality surge protector is to be used. The computer can be picked up at one of our site offices or a shipping and handling fee of \$50 will be deducted from my family account; computers will not be available until after September 15th.

I understand that if I withdraw from CyberLynx prior to the third year, the computer must be returned at time of withdrawal. I understand that if I do not return the computer or pay the remaining payment(s) within sixty days of withdrawal, the computer will be reported to the authorities as theft.
